Safe haven location (JTR, Table 6-5)	Determined by authority that directs evacuation..	Same as military dependents
Safe Haven allowances (combination of lodging, meals and incidentals)	Ordinarily short term, but could be up to 180 days with exception. First 30 days: Dependents age 12 or older receive up to 100 percent of the locality per diem rate. Dependents under age 12 receive up to 50 percent of the locality per diem rate. Days 31-180: Dependents age 12 or older receive up to 60 percent of the locality per diem rate. Dependents under age 12 receive up to 30 percent of the locality per diem rate. If dependents of Service members, civilian employees, or dependents of civilian employees remain in their home and choose not to evacuate, they are not authorized safe haven or special allowances for subsistence.	Same as military dependents
Escort for Dependents (JTR 060203)	YES A Soldier may be authorized round trip to escort dependents incapable of traveling alone to the safe haven	NO
Unaccompanied Baggage	Dependents age 12 or older: up to 350 pounds Dependent under age 12 up to 175 pounds for a total of 1,000 pounds	NO
