#### Why we are writing

We are writing to provide you with information about the upcoming third and final phase of the SBP-DIC Offset Phased Elimination. The third and final phase begins in 2023.

You will see the **Phase Three change** in your Survivor Benefit Plan (SBP) monthly annuity payment made on **February 1, 2023**.

The SBP-DIC offset will be fully eliminated as of January 1, 2023. That means you will begin to receive your full SBP payments with no offset (reduction) on February 1, 2023. You will also continue to receive your **full DIC payments from the VA**. SSIA will no longer be paid.

#### What you need to know

In 2020, Congress made changes to the Survivor Benefit Plan (SBP) to phase out the SBP-DIC offset, which is a reduction of SBP for surviving spouses who also receive Dependency and Indemnity Compensation (DIC) from the Department of Veterans Affairs (VA).

January 1, 2023 begins Phase Three of the "Phase-Out of Reduction of Survivor Benefit Plan Survivor Annuities by Amount of Dependency and Indemnity Compensation," as directed by the National Defense Authorization Act (NDAA) for Fiscal Year 2020.

Because of this change in the law, in 2023 surviving spouse SBP annuity payments issued by the Defense Finance and Accounting Service will **NOT be reduced** by DIC (issued by the VA). Eligible surviving spouses will receive the full amount of their monthly SBP annuity payment plus they will **continue to receive the full amount of DIC** from the Department of Veterans Affairs.

Remember, this change in the law does NOT affect your DIC payments. You will continue to receive your normal DIC payments from the VA.

The Special Survivors Indemnity Allowance (SSIA) will no longer be paid.

To help you understand how the 2023 changes will affect your SBP payment, we *pre-estimated* the amount on the following page. Please note this pre-estimate is based on current information (with a 8.7% COLA), and the actual amounts in 2023 may differ slightly from the pre-estimate.


# The SBP-DIC Offset Phased Elimination 2023 Changes

# Phase Three - 2023

\*Please see our SBP-DIC News webpage for FAQs: <u>www.dfas.mil/sbpdicnews</u>\*

In the third and final phase (2023), the SBP-DIC **offset** will be fully eliminated. That means you will begin to receive your **full SBP gross benefit** payment with no offset (reduction). The first payday for Phase Three is **February 1, 2023**. You will also continue to receive your **full DIC** payments from the VA. SSIA will **not** be paid after the January 3, 2023 payday.

# Monthly Payments Starting in Phase Three:



# Example

- ◆ If **DIC** benefit (paid in full by the VA) equals = \$1437.66
- ◆ And SBP gross benefit (paid by DoD/DFAS) equals = \$940

## Monthly Payments Based on Above Example:

Monthly payments beginning February 1, 2023 (first payday of Phase Three):

\$1437.66 DIC from VA + \$940 Gross SBP from DFAS

- ♦ DIC benefit (paid in full by the VA) = \$1437.66
- ♦ SBP gross benefit (paid in full by DoD/DFAS) = \$940 (before taxes) (No SSIA is paid after January 3, 2023)

# The SBP-DIC Offset Phased Elimination 2022 Changes

# Phase Two - 2022

In Phase Two (2022) of the offset phased elimination, your SBP gross benefit is reduced by an amount that is equal to one-third of your DIC benefit. This does NOT affect your DIC payment, which is paid by the VA. **The first payday for Phase Two was February 1, 2022 and the last payday for Phase Two is January 3, 2023.** 

## Monthly Payments During Phase Two:



# Example

- If **DIC** benefit (paid in full by the VA) equals = \$1437.66
- ◆ And SBP gross benefit (paid by DoD/DFAS) equals = \$940
- Offset to SBP (DIC benefit amount divided by 3) equals = \$479.22
- ◆ SBP net payment after offset (reduction) of \$479.22 equals = \$460.78

#### Monthly Payments Based on Above Example:

Monthly payments beginning February 1, 2022 (first payday of Phase Two):

\$1437.66 DIC from VA + \$460.78 Net SBP from DFAS + \$346 \*SSIA from DFAS

- DIC benefit (paid in full by the VA) = \$1437.66
- ◆ **SBP net** payment (paid by DoD/DFAS) = \$460.78 (before taxes)
- \*SSIA payment (paid by DoD/DFAS) = \$346 (\*SSIA paid ONLY when SBP gross is reduced due to offset; up to maximum of \$346 in 2022)

Please note: a small number of spouse annuitants (approximately 12%) will NOT see an increase in their SBP net payment in 2022. This is because one-third of their DIC benefit (the offset) is more than their SBP gross benefit. This group of spouse annuitants WILL receive their full SBP gross benefit beginning February 1, 2023 (see page 1).

DIC = Dependency and Indemnity Compensation paid by the Department of Veterans Affairs (VA)

SBP = Department of Defense (DoD) Survivor Benefit Plan

SSIA = DoD Special Survivor Indemnity Allowance

 $\mathsf{DFAS}=\mathsf{Defense}$  Finance and Accounting Service; the DoD agency that processes Survivor Benefit Plan (SBP) and SSIA payments

# **Eligibility Verification**

SBP annuitants need to verify their continued eligibility regularly to receive SBP annuity payments. There are several types of verification.

## **Tax Statements**

Survivor Benefit Plan (SBP) payments are federal taxable income. State and local taxes vary.

We have easy, convenient options to get a copy of your **1099-R** tax document without having to call to speak to someone.

Your 1099-R is available much earlier and more securely in **myPay** than those sent to customers who choose delivery by mail. If you're not using myPay, now is the time to get started.

Even if you are not a myPay user, you can get a copy of your 1099-R sent to your mailing address on record or to a one-time, temporary mailing address by submitting your request online through askDFAS.

### Using myPay to Manage Your Payment Account

Once you begin **receiving SBP annuity pay** through DFAS, you can use myPay.

myPay provides online access to your Annuitant Account Statement, and lets you update your contact information or your federal tax withholding, submit your annual certification (COE), or download your tax documents.

If you've never used myPay, you can request an initial password on the myPay homepage using the "Forgot or Need a Password" link. The password will be mailed to the address you have on file with DFAS and you will receive it in about 10 business days. Once you receive your password in the mail, you can return to the myPay homepage and log in with your social security number and the password you received in the mail to create your myPay profile.

myPay is available using the internet from your computer or your mobile device browser at: https://mypay.dfas.mil

#### **Annuitant Account Statements**

The Annuitant Account Statement (AAS) is available through myPay. For those annuitants who have a hardcopy mail request in their account, it is mailed when changes are made to the account that affect net pay. Use it to verify payment, tax information, and to keep informed about your account.

# **Status Notifications**

We are rolling out the use of status notifications to keep you in the loop as forms or documents you submit move through the annuity pay processing cycles. Right now, only a few documents have status notifications available, but we are adding more each month.

Status notifications are a three-step process that will update you when DFAS receives forms or documents for processing by mail or fax (or in some specific cases, through askDFAS).

You will receive separate status notifications when your form or document is:

1. Received and queued in the DFAS work system

2. Assigned to be worked

3. Completed - Either a notification the processing is complete or a notification that DFAS is sending a request for additional information.

Status notifications will give you peace of mind that we received your form or request. They will also provide you with the timeframe when we completed your request or notify you if additional information is required.

To receive status notifications for mail and fax submissions, please ensure your email address is available and updated in myPay. Most notifications are sent via SmartDoc email, which require a valid email address in myPay.
